CRITERION TO BE AN AFFILIATED MEMBER

1. Only clubs, societies and such body or organisations which are registered under the laws of Singapore governing the registration of such clubs, societies, bodies or organisations and which are established with the principal or ancillary object of promoting the sport of Karate-Do in line with the Federation may apply.
2. Applicants will submit and accept unconditionally, the by-laws and constitution of the SKF.
3. Applicant must submit a non-refundable application fees of \$150.
4. Applicants must be an established Karate-Do Club in the Republic of Singapore for at least 3 years.
5. Applicants must have a minimum of 250 active paying members in their organizations.

7. Applicants must agree to the terms and conditions of admission as set by the Management Committee.
 8. Upon the acceptance of the terms and conditions of admission as set by the Management Committee, the applicants will first become "PROVISIONAL MEMBER" of the Federation for 4 years without any voting rights. They must pay one-time non-refundable entrance fee of \$2,500 together with an annual fee of \$250.00 upon acceptance as a Provisional Member of the Federation.
 9. Provisional Member will only be eligible to be qualified for consideration as a full member after fulfilling all such conditions and payment of all fees as prescribed. Only upon satisfaction of all conditions will the Management Committee approve the Provisional Member to become a full member of the Federation in accordance with the rules of the SKF.
